# **Executive summary**

The following report covers the period from July to September 2019, including the environment, social, health and safety and human resources areas.

Condor continues to implement its Environmental and Social Management System, which includes Environment, Community, Health and Safety and Human Resources. Focus was put on the baseline studies for the EIAs of Tatiana and America feeder pits, which included: hydrology and hydrogeology studies, forestry inventory, fauna study, ARD study, noise and air quality studies, and water management. Other activities include environmental awareness with coworkers and villagers, maintenance of recycling containers, composting of organic waste, maintenance of the tree nursery and the implementation of the Reforestation Plans in Real de la Cruz, Espinito-Mendoza and La India concessions.. Environmental monitoring continues for the La India project, including groundwater, surface water and weather data from our digital weather station and three other rain gauges. Furthermore, the second quarter environmental report was presented to the villages. Presentations in La India, El Bordo and Agua Fría villages covered the environment, geology and social areas.

The tree nursery "Oro Verde" holds a total of 4,410 plants, which are watered, fertilized and kept clear of weeds and pests as part of its maintenance program. Condor also received from INAFOR, 250 trees to ensure their survival in the tree nursery. This quarter, a total of 182 plants were donated to schools, and government institutions for their environmental campaigns, 533 were planted in the reforestation area in La India concession called Nance Dulce, 200 *Glicidia sepium* and *Bursera simaruba* cuttings were planted in Espinito-Mendoza concession.

Condor continues implementing the Reforestation plans for Espinito-Mendoza and Real de la Cruz concessions, and added two new reforestation areas in La India concession; the one in Nance Dulce and another one in Alfa 6. Also, a new area has been added in the Real de la Cruz concession to comply with the compensation plan commitment.

The social area continues to work on strengthening our social license with neighboring villages to the mining project through various relationship programs and various communication actions with stakeholders.

Company's social investment has focused on seven social programs: **Contributions and Donations** (which address issues related to education, health, sports, village mourning, among others) benefiting a total of 68 people and organizations during the quarter; **Fresh Water** (this program benefits 365 families from Santa Cruz de la India, Agua Fría villages and 26 property owners); **Seniors** (with 78 members), **APROSAIC** (working with villages surrounding the project), **Agua Es Vida** (members actively working on improving the water availability for the community of Santa Cruz de la India,143 members), **Business** (with 52 entrepreneurs) and **Small Mining** (benefiting 277 artisanal miners organized in 65 groups).

This quarter, we carried out activities that allowed us to strengthen relations with the villages, generating trust and appropriation with the project such as: the celebration of national holidays with students from 03 schools, celebration of grandfather's day, celebration of National Miners' Day with non-cooperated miners from La Mestiza, in addition to multiple meetings with local and municipal stakeholders. Moreover, five press releases were also shared on the project's outstanding activities and programs.

During the period, Condor had 52 direct employees: 58% live in the local villages, 38% are women. 3 employees have been or are benefiting from a scholarship for English courses. Condor employs 38 people indirectly through the security company ESIPSA.

#### 1. INTRODUCTION

This report is part of Condor Gold's commitment to continuous improvement and monitoring of the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social and Community Relations, Health and Safety and Human Resources; ensuring transparency with its shareholders and relevant stakeholders.

#### 2. OBJECTIVE

To inform stakeholders about the implementation of the Environmental and Social Management System in the areas of Environment, Social and Community Relations, Health and Safety and Human Resources during the third quarter 2019

#### 3. ENVIRONMENTAL ACTIVITIES

#### 3.1. ENVIRONMENTAL MONITORING

#### 3.1.1. Baseline studies

Condor Gold continues conducting groundwater level, surface waterflow and water quality monitoring, as well as gathering weather data from its digital weather station and three rain gauges.

The environmental baseline studies for the Tatiana and America open pits projects were completed based on the Terms of Reference of the EIA application process.

## Surface waterflow

Monitoring of weirs continues. Constant water flow is only present in San Lucas V-notch weir (LIWR001), which showed a decrease from 18cm in the last quarter to 15.8cm in September; since during this period rainy events were scarce due to the "canicula" (an dry period within the rainy season which can go from 15 to 30 days) effect (Photos 3.2.1.a-e). Even though the rainy season started mid-May, no constant water flow has been established in any of the weirs being monitored.

A study to install a new weir in El Quebrachal basin, downstream of the America project, is underway. The site visit of the consultant to locate the new weir in El Quebrachal stream was completed, and a place was selected downstream, with access to a road. The final study with the estimated cost of construction will be provided in the first week of October. However, El Quebrachal stream currently does not have water flowing, even though we are in the middle of the rainy season.

#### **Groundwater level monitoring**

Weekly monitoring continues. Five new sites located within America and Tatiana projects and surrounding area were added. All of them are hand-dug wells. One of them LIWL062 is dry at 17.67m. The other four have been added to the weekly monitoring program. In total, 25 sites are being monitored since July 2019.

In July, 13 sites showed a decrease in groundwater level of between 0.03 m and 1.38m. The highest belongs to LIWL040 (hand-dug well), followed by LIWL011. An increase was seen in 5 sites, between 0.06 and 0.83 m. The highest one was hand-dug well LIWL056. Usually, high variations in hand-dug wells reflect the fact that they are being used by the landowners.

In August, 7 sites showed a decrease in groundwater level between 0.05 m and 3.19 m. The highest belongs to LIDC047. An increase was seen in 13 sites, between 0.01m and 1.15m. The highest one was hand-dug well LIWL046.

In September, 6 sites showed a decrease in groundwater level between 0.04 m and 6.36 m. The highest belongs to LIWL056, a hand dug well use for cattle. Drill holes showed decreases between 0.05 and 0.52 m. 14 sites showed an increase between 0.03m and 1.81m. The highest one was hand-dug well LIWL063, which usage has been discontinued or reduced due to the drilling of a water well next to it, with depth of 45.72 m (150 ft). Changes in groundwater levels of drill holes were between 3 to 18 cm.

The final document of the hydrology, hydrogeology and climate study for the baseline studies of Tatiana project was received. It included water quality study, infiltration tests. The study for America was done previously.

#### Weather data

Condor continues registering weather data gathered from the digital weather station and three rain gauges located in Agua Fría village, La India village in La India concession and one in Espinito-Mendoza concession.

Based on Condor's weather station, the following data was registered during this quarter:

<sup>\*</sup> The difference in rainfall registered by Condor digital station and the manual rain gauges raises the possibility of technical damage of the rainfall sensor. A manual rain gauge will be installed during October in the same location of the digital station and comparisons will be made to confirm values registered.

#### **Air Quality**

The air quality and noise study were completed for 14 sites. The sites included existing access roads, and sites within the proposed area of interest for each project: Tatiana and America. The study was done by the laboratory PIENSA-UNI, which belongs to the National University of Engineering.

None of them exceeded the threshold stablished by Nicaraguan law, nor the WHO standards for sulfur dioxide ( $SO_2$ ), carbon monoxide (CO), lead (Pb), ozone ( $O_3$ ), Particulate Matter of 10 microns or less ( $PM_{10}$ ), Suspended Particulate (PTS in Spanish), and Nitrogen dioxide ( $NO_2$ ).

#### Other baseline studies

The study for soil characterization was completed for both projects and the ARD study included 53 samples for analysis. The preliminary document will be received mid-October.

The studies on Fauna and a forestry inventory were completed in July, covering the America and Tatiana (La Mestiza) feeder pits. The forestry inventory considered trees over 30cm diameter, as the law states, identifying approximately 3 trees per hectare in Tatiana and 19 trees per hectare in America.

#### 3.2. ENVIRONMENTAL MANAGEMENT

Condor continues implementing the Environmental and Social Management System, in compliance with internal policies and international standards.

This quarter, work was focused on the baseline studies for the EIAs of Tatiana and America feeder pits, which included: hydrology and hydrogeology studies, forestry inventory, fauna study, ARD study, noise and air quality studies, and water management quotes.

Other activities included the 5-minutes talks with workers related to environment, solid waste management, water management; an environmental workshop was conducted by the environmental team in Macizo de Peñas Blancas Natural Reserve; talks with children in schools of the seven surrounding villages, which included the installation of signs related to fire prevention, reforestation and waste management; maintenance of recycling containers, composting of organic waste, maintenance of the tree nursery and the implementation of the Reforestation Plans in Real de la Cruz, Espinito-Mendoza and La India concessions. Also, the environmental area continued its support to the social project "medicinal herbs garden" from the Seniors Program.

Furthermore, this quarter, the second quarter environmental report was presented to the villages. Presentations in La India, El Bordo and Agua Fría villages covered the environment, geology and social areas.

#### 3.2.1. Environmental Management System implementation

This quarter, Condor continued implementing and promoting environmental awareness, environmental education, waste management (composting and recycling), water management and soil conservation through reforestation.

sA part of promoting environmental awareness, this quarter, talks with workers were related to the environmental permit, water usage and importance, 2nd quarter environmental report, air quality, importance of planting a tree, solid waste management, the importance of environmental services, the experience/impact of the workshop in the natural reserve.

Four large signs were installed in La India, Agua Fría, El Bordo villages, as well as at La Mestiza property, in coordination with INAFOR and Santa Rosa del Peñón municipality and are related to forest fire prevention, solid waste management and reforestation. Seven smaller signs were installed in each school of the seven villages (Ocotillo, Nance Dulce, El Carrizal, El Cristalito, La India, El Bordo and Agua Fría) with the approval of the Ministry of Education (MINED). These were accompanied with an environmental awareness talk on forest fire prevention, solid waste management and reforestation, reaching a total of 160 kids and teachers.

Recycling and composting activities continued this quarter, the worms of the vermicompost area were replaced, but the worms were transferred to a new composting area. Recycling continued internally as well as with the villages. A total of 60 lb of paper/cardboard and plastic have been collected internally this quarter for recycling. General waste was on average 250 lbs/month and organic waste was about 250 lbs/month.

A total of 145 bags of plastic bottles were donated to MARENA-León for the project "Nica bardas", a municipal initiative to retain floating garbage from rivers. Three new metallic containers for plastic bottles were prepared and installed in the security posts to promote recycling. A total of 30 lb of PET were collected in Espinito-Mendoza concession.

As part of the remediation and biodiversity conservation, Condor continues with its tree nursery in La India concession and its water reservoir in Espinito-Mendoza concession. This quarter, Condor added a new reforestation area in Nance Dulce village, where 533 trees were planted across one hectare, adding to the two pre-existing reforestation areas Real de la Cruz and Espinito-Mendoza concessions. Only one hectare of the new area in Real de la Cruz for the compensation plan of the environmental commitments of the exploration permit will be

covered this year, due to the long dry period within the rainy season and setbacks with the original area proposed.

Maintenance was also carried out on the existing 8 ha reforestation areas in Espinito-Mendoza concession and Real de la Cruz concession. All these activities contribute to biodiversity and water conservation, soil conservation and environmental protection.

## 3.2.2. Tree Nursery "Oro Verde"

The tree nursery "Oro Verde" provides the trees for all reforestation areas in the Condor concessions. Maintenance of the tree nursery continued, which includes watering, fertilizing and weed control.

A total of 4410 plants are watered, fertilized and kept clear of weeds and pests as part of the maintenance program of the tree nursery Oro Verde. In August, 97 plants were donated to INAFOR and El Jicaral municipality. Other plants were used in the reforestation areas. Maintenance of the infrastructure was done, continuing the Bamboo replacement. In September, 60 plants were donated and participated in the Inauguration of the Reforestation campaign in El Jicaral municipality, León department. For the talks in schools, 25 trees were donated, and 533 trees were planted through the reforestation campaign in Nance Dulce reforestation area, in La India concession.

228 new seedlings of *Ceiba penthandra* outed sprung in the tree nursery and 250 trees were transferred to the tree nursery and donated by INAFOR to be taken care and ensure their survival.

An area in ALFA 6 (a location of the company) is being prepared to plant 140 trees in compensation for 14 trees cut down in the camp area due to remodeling of the parking lot, as agreed with National Forestry Institute (INAFOR).

#### 3.2.3. Implementation of reforestation plans and activities

#### 3.2.3.1. Espinito-Mendoza concession – reforestation plan

In July, 200 aplings *Gliricidia sepium* and *Bursera simaruba cuttings* were planted in the reforestation area of Espinito Mendoza concession, as part of a reforestation activity done with workers on 3<sup>rd</sup> July celebrating National Tree Day.

The forestry inventory as part of the EIA baseline studies in Tatiana feeder pit was completed. Other baseline studies such as fauna, infiltration tests and water sampling took place in the concession.

In August, maintenance of the reforestation area continued. A new area will need to be assigned to replace the 5 ha of reforested area, which will be affected by the Tatiana (La Mestiza) exploitation project, on which an EIA is underway.

The baseline studies for Tatiana exploitation project EIA area underway. The hydrology and hydrogeology study were completed, and the final version is pending, air quality study was also covered and the ARD study is underway. Site visits were done during this month.

In September, activities related to waste management were conducted with the artisanal miners located within La Mestiza property, involving talks with artisanal miners and recollection of plastic bottles from the container located there for that purpose. A total of 30 lb of PET were collected. Also new containers were installed as part of the maintenance of the waste management program.

A meeting with top management and Information Technology area was held to identify potential areas for the replacement of the 5 ha of reforested area, which will be affected by the Tatiana (La Mestiza) exploitation project. A further discussion will take place and potential agreements with landowners may be required.

The baseline studies for the EIA in the Tatiana concession are underway as detailed in previous sections. The EIA document is expected to be ready in the 4<sup>th</sup> quarter, if the final technical documents (designs of the installations) are delivered within the timeframe as established.

#### 3.2.3.2. Real de la Cruz concession – reforestation plan

In Real de la Cruz concession, preparation for the area and watering of the existing trees (since this month rain has been scarce) have been the principal activities. Only 424 trees were planted in replacement of the those that died last year in the 3 hectares reforested area, due to the harsh weather conditions.

The new area for the compensation plan has been selected as part of the commitment. 2.9 hectares will be reforested between 2019-2021, in compliance with the environmental permit.

#### 4. SOCIAL ACTIVITIES

#### 4.1. STAKEHOLDERS ENGAGEMENT IMPLEMENTATION

## 4.1.1. Meetings with local stakeholders

During this quarter, the company held 44 meetings with leaders of different social programs to coordinate activities carried out with village's program's members in general. Main topics addressed were:

- Water program
- Elderly program
- Social contributions
- Business Program
- APROSAIC
- Artisanal Miners

#### 4.1.2. Bilateral meetings with local stakeholders

#### **Bilateral meetings**

During this period, the company held 29 bilateral meetings, with local organizations in the Direct Influence Area (DIA) and with NGOs and/or institutions interested in collaborating on social programs.

#### Collaboration alliances meetings

# 4.1.3. Artisanal mining

Within the artisanal mining program, the following activities were carried out:

## a) Miners' Board of Directors' activities (COOPTRAMIN)

#### √ National Miner's day

In commemoration of National Miner's day, Condor Gold in coordination with the Board organized a gathering for 60 members of the cooperative who participate in the involvement group from Talpetate, Mina La India, Bordo, Nance Dulce and Cristalito villages. As part of this, all members enjoyed snacks and received a souvenir; furthermore, food packages were given the older members who could not attend the activity.





## √ Visit to Leon's journalists

In July, two members of each of the artisanal miners involvement groups provided 9 interviews to 8 radio stations and one TV channel from Leon promoting National Miners Day and providing information regarding the work conducted with Condor Gold for the benefit of the artisanal miners sector in La India mining district.





### ✓ Dental open clinic

In July, Condor Gold in alliance with UNAN-Leon developed the Dental open clinic for cooperative members who participate in the involvement group. A total of 26 members participated and received services such as prophylaxis, resin tights, dental extractions and oral hygiene kits.





#### ✓ Participation in Baseball Match at the National Stadium.

As part of the relation developed with members of cooperative, the board members held a visit to the National Baseball Stadium with cooprative members. 12 tickets were raffled to attend the Nicaragua vs Cuba match during activities held by the involvement group in June.

The winners appear to have enjoyed the great experience. Each one expressed that it was a unique experience to see such a game and even more at the National Stadium: "we are thankful and we hope that activities like this continue to targetfocus on miners since our communities are fans of baseball.





#### ✓ Playground improvement in Talpetate school

As part of the close relationship with cooperative members in each community, a group of miners through the board presented a request for improving the playground area of Talpetate school as children do not have a recreational area in which to play.

A contribution was made by providing material for construction of two swings structures (4 swings each structure) and paint for a classroom; also, a reforestation campaign was run, providing 135 trees. The board and local miners provided the labour for this this activity.





#### ✓ Participation on Bishop's visit to Santa Rosa

Board members participated in the mass celebrated by the new Bishop of Leon, who was made aware of the close relation that the company has with the cooperative.



Representatives of COOPTRAMIN participated in the meetings and expressed the importance of such ID card since the current card is out of date (1999) and that it would be great to have it updated. The cooperative agreed to start the process in October because of the support of Condor Gold in providing the assistance for ID process.



#### b) Activities with the Board of Independent Miners and work in La Mestiza

#### √ National Miner's day

In commemoration of National Miner's day, Condor Gold in coordination with the Board carried out a celebration of 180 artisanal miners in La Mestiza area. Several contests took place, with prizes including tools commonly used in their mining activities. The board oversaw the event, withartisanal miners providing lunch for all attendants.

FurthermoreMAKITA (an equipment supplier) participated with gifts of souvenirs to artisanal miners and MEM (DGM) delegate.





## Improvement of road to La Mestiza

Board members and groups leaders agreed to raise money to improve the road access to La Mestiza. Since the budget was higher than expected to repair critical areas, the board requested support from the company to execute the repair of 500 meters of internal road into the property.

#### **National Health and Safety Day**

The National Health and Safety day was celebrated August 20<sup>th</sup> with a cultural event in La Mestiza with the participation of 96 artisanal miners and the local priest, who delivered a speech about safety. The event was organised to promote the importance of safety in all kind of work, especially in mining.

#### ✓ National Simulacrum: accident in San Juan area

More than 300 independent artisanal miners participated in a national (drill)simulation. The local scenario was an earthquake with detachment of material in a tunnel or mining work area, to raise awareness among artisanal miners of the importance of being organized and prepared for a disaster.





## c) Inspections of risks at extraction sites carried out in La Mestiza:

During this quarter, a total of 34 geo-technical inspections were done to analyse safety aspects from each mining site.





In July the implementation of the mandatory usage of safety equipment for artisanal miners to access La Mestiza property started.







All groups had accomplished the usage of safety equipment and enrolment to social security. A total of 24 groups with 103 artisanal miners have access permits to La Mestiza.

## 4.1.4. Communication campaigns

During this quarter, we continue to execute the communication strategy using various methodologies such as: assemblies, bilateral meetings, home visits, Facebook, YouTube and website. With the use of these communication channels we managed to be in direct contact with the population.

As part of the public relations strategy, there were communications:

- Artisanal miners thank La India Gold for support.
- La India Gold promotes Seniors Program to improve people's life quality of citizens over 60 years old in Santa Cruz de la India
- Condor Gold talks to its workers and artisanal miners on occupational safety, this was published in 6 digital media.
- La India Gold promotes mural contest on responsible use of water.
- Short press release on Facebook entitled: Gastronomic exhibition.

In addition, two miners from the cooperative and independent miners' program participated in a visit to eight media outlets to discuss the celebration of the National Miners Day.



#### Fresh Water Program in Santa Cruz de la India

During this third quarter, Agua Fresca program continued to evolve, two free purified water canisters and two subsidized purified water canisters are provided every month, benefiting 365 homes in Santa Cruz de la India and Agua Fría villages.

We also provide support to vulnerable groups: the elderly, people with disabilities and multihousehold families through the free delivery of the four water canisters. The company supports the reduction of water scarcity and diseases linked to polluted water.

In Santa Cruz de la India village, 2,682 purified water canisters of fresh water have been delivered in this period to 239 families.

#### Fresh Water Program in Agua Fría village

Fresh Water program reaches every home in the Agua Fría village, also permanently and benefiting families where there are seniors and people with disabilities.

1,459 purified water canisters have been delivered in the village from July to September.

#### Activities within the program:

- In the Agua Fría village, families are still visiting and an enrollment in the program was conducted.
- 126 families receive their purified water canister weekly

## 4.3. IDENTIFICATION OF VULNERABLE FAMILIES

#### Seniors Program Santa Cruz de la India

In Santa Cruz de la India there are 125 seniors who are part of the most vulnerable sector in the village. AAs part of the work strategies, activities have been developed for physical, mental, spiritual stimulationand activities that integrate them into an active life.

Older adults participate in program activities for various reasons such as: fun, opportunity to do something for their village and their health.

Recreational celebrations were held through relationship and outreach activities to maintain closeness and involvement of all program members. To date there are 78 active members, 50 participate in activities, the others present some physical impediment.

This quarter, the medicinal garden pilot project was continued with the participation of 6 older persons, this project aims to become a self-sustainable project that provides income to its members and is very useful for village residents as it will be the first garden that will provide natural medicine.
