Condor Gold has developed an internal prevention protocol with our employees, which includes sanitary measurements within the installations and towards the surrounding communities, such as:

- Talks given and written pamphlets on sanitary measurements and COVID-19 prevention were distributed to employees.
- Avoid social gatherings as much as possible and promote social distancing in common areas.
- Use of masks for employees is obligatory in the installations and villages.
- Cleaning outside and inside of vehicles after each use.
- Alcohol spray (small) is distributed for all employees and for desk/computer cleaning.
- Benzalkonium chloride is distributed for all the employees to use in their houses to clean surfaces.
- Disinfectant booth, washing hands, shoe disinfection and thermometers are used at the entrance of the offices.
- Suppliers are met outside the office areas to reduce contact with employees.
- Guidelines for kitchen area and cleaning procedures have been modified and the use of common items has been eliminated.
- Villagers in the social programs and local schools have received talks, as well as sanitary supplies (alcohol, chlorine, etc).

As of November 2020, Condor Gold resumed normal activities, all employees working full time, but with sanitary measurements and social distancing and sanitary measurements being implemented to avoid spreading of Covid-19 and ensure the safety and health of its employees and surrounding communities.

Executive summary

Condor continues to implement its Environmental and Social Management System, which includes Environment, Community, Health and Safety and Human Resources. Activities were restarted in November with sanitary measurements and social distancing in place.

The environmental work was focused on monitoring the level of groundwater and surface water, monitoring climatic parameters, water management, waste management and recycling, maintenance of the plants in the "Oro Verde" nursery and maintenance of 8 reforestation areas located in La India and 2 in Real de la Cruz concessions. Daily 5-minute talks were given to workers on environmental, industrial and social safety issues; support was provided to different areas of the company; environmental awareness activities were also carried out with workers from the environment and social area; participation in the national reforestation plan, through the donation of plants requested by INAFOR, city mayors, MINED and Sandinista Youth, as well as nearby communities.to the area of influence of La India mine project; and support for León zoo as part of company's Biodiversity program.

Other activities included the preparation and delivery of quarterly environmental reports to government institutions. The company accompanied MEM as part of a complaints procedure against artisanal mining located in Real de la Cruz Concession, which did not have authorization from the property's owner- Condor was summoned to participate (support as owners of the Concession). The first water monitoring was coordinated as part of the Hydrology Baseline; delivery of reports to all competent Institutions (MARENA, MEM, Municipalities and MINSA), a meeting was held with the Santa Rosa del Peñón Municipality on the preparation of the project profile document and PGA to be presented to MARENA; tree cutting activities were carried out in the sector on the way to mestiza as part of the safety to workers, since, due to rains, there were several incidents of falling trees; property fencing activities were carried out and in April 8 forest fires were extinguished.

The social area continues to work on maintaining the social license with every community neighboring the mining project through various relationship programs and various communication actions with stakeholders.

The company's social investment has focused on social programs: Contributions and Donations (addressing issues related *inter alia* to education, health, sports, community mourning; during this period, 44 contributions were delivered to individuals and organizations), Agua Fresca (program benefits 458 families from Santa Cruz de la India, Agua Fría and 26 property owners), Seniors program (85 members), APROSAIC (works with the communities neighboring the project), Agua es Vida program (which has 135 members), Businesses program (comprising 55 entrepreneurs), Youth en Acción program (which benefits 21 youth) and Happy Childhood (which benefits 38 children).

1. INTRODUCTION

This report is part of Condor Gold's commitment to continuous improvement and monitoring of the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social and Community Relations and Human Resources; ensuring transparency with its shareholders and relevant stakeholders.

2. OBJECTIVE

To inform stakeholders about the implementation of the Environmental and Social Management System in the areas of Environment, Social and Community Relations, and Human Resources during the third quarter of 2021.

3. ENVIRONMENTAL ACTIVITIES

3.1. ENVIRONMENTAL MONITORING

3.1.1.1. Surface waterflow

- The monitoring of surface water levels continues in 6 different sites within concession areas, 5 located in La India sector and 1 in the Americas sector.
- For this quarter there is a continuous flow in San Lucas tunnel located in Ocotillo sector, as well as instantaneous flows in La Simona landfill; the flow behavior in both sites and in the rest of landfills is the product of rainfalls that occurred in the project area, and accumulation of groundwater in the sector of the old La India Mine (the old San Lucas adit). The variation of flows in San Lucas Ocotillo landfill for this quarter is in the range of 23 to 56 lps, with an average of 32.66 lps; the variation is due to rainy period which has been established to be above normal in these months compared to last year.




Figure 1.1.1 a. Comparative behavior of water levels vs precipitation in San Lucas Túnel - Ocotillo.

- Regarding La Simona landfill: the basin began the generation of instantaneous flows in this monitoring site from May, registering a maximum value of 372.7 lps in May and 28.1 in June - the following graph shows the behavior of the maximum flow days.




Figure 1.1.1 b. Comparative behavior of water levels vs precipitation in La Simona Landfill.

3.1.1.2. Groundwater level monitoring

- LIGSA carries out the continuous monitoring of groundwater levels in 24 wells / piezometers distributed within its main concession areas and checks these on a weekly basis.
- The variation of static water levels in the current network fluctuates according to its location with respect to the geomorphology and depth of the wells whose range is between 1 and 398 m, and whose water levels for this quarter are in the range of 10 to 132 m, with average values in the range of 63 m deep for deep drilled wells, in the case of intermediate depths the range is established between 0.3 and 18 m with an average value of 10 m, and 2.25 m for shallow wells.




Figure 1.2.1 a. Comparative behavior of groundwater levels in La India concession.




Figure 4.1: Data history of the Condor S.A Digital Station – 2020 – 2022




Figure 4. 2: Comparative data of the manual Station-2022

The company, through the hydrology area works together with technicians from the Mayor's Office of Santa Rosa del Peñón, the National Water Authority (ANA), the Social Investment Fund (FISE) and ENACAL are in the process of generating technical and baseline information to be used in the formulation of the project with an overall progress of the feasibility study of 75%

- LIGSA carries out continuous groundwater level monitoring of 16 wells / piezometers distributed within its main concession areas and collects data weekly.
- The variation of static water levels in the current network fluctuates according to its location with respect to the geomorphology and depth of wells range is between 3 to 40 m- and water levels for this quarter are in the range of 0.54 to 29 m, with average values of 16 m deep for drilled wells and 0.52 m for dug wells.




Figure 1.2.1 a. Comparative behavior of groundwater levels in La Mojarra concession.




Figure 1.2.1 a. Comparative behavior of groundwater levels in the Espinito Mendoza concession.

CONCLUSIONS.

- 1. LIGSA through its hydrological monitoring programme is in compliance with the requirements established in accordance with the Law and current technical standards linked to the environmental permits and operational activities of the project.
- 2. Flows in the area: Runoff at the surface level has experienced substantial increases due to the occurrence of large accumulated rainfall for this quarter (708 mm) generating maximum peaks of 372 lps in the month of April and 28.1 lps in May. At the underground level there is an overall decrease in flow that emerges from the San Lucas tunnel in Ocotillo, going from 24 lps to 32 lps, with a maximum recorded in June of 57.72 lps.
- 3. The groundwater levels in the same context are presented with variations between 0. 2 to 8 m deep in dry period -recorded in April- the trend is to increase as the rainy season advances.
- ARD / The first collection of leachate sample corresponding to the accumulated water was carried out in the months of April and May. 8 liters of sample per reactor are preserved (-0°c), for a total of 64 liters of leachate including rainwater.
- 5. The climate variables show an above normal behavior for the first months of the rainy season, mainly in May where the cumulative amount exceeded 380 mm of precipitation versus the cumulative amount oof 22 mm registered in 2021. There is a prospect of a rainy period above normal, the records may exceed the cumulative means of the historical norms for the project area.
- 6. The technical support of Hydrology area to the inter-institutional technical commission (ANA-FISE-ENACAL-Alcaldías) continues for the formulation of the drinking water project of India and Agua Fría. To date an advance of 75% in the feasibility studies is estimated.

7. Technical support to the operational activities of the La India water purification plant continues.

3.2. ENVIRONMENTAL MANAGEMENT

Condor continues to implement its Environmental and Social Management System, in compliance with internal policies and international standards.

The environmental work was focused on monitoring the level of groundwater and surface water, monitoring climate parameters, water management, waste management and recycling, maintenance of the plants in the "Oro Verde" nursery, and maintenance of 6 reforestation areas located in La India and 2 in Real de la Cruz concessions. Daily 5-minute talks were given to workers on environmental matters, industrial and social safety issues, support was provided to the different areas of the company; Environmental awareness activities were also carried out with workers from the environment and social area, participation in the national reforestation plan, through the donation of plants requested by INAFOR, MARENA, Mayors, MINED and Sandinista Youth, as well as to community members close to the area of influence of the La India mine project, support for the León zoo as part of the Biodiversity program.

Other activities included the preparation and delivery of quarterly environmental reports to government institutions. The company accompanied MEM as part of a complaints procedure against artisanal mining located in Real de la Cruz Concession, which did not have authorization from the property's owner - Condor was summoned to participate (support as owners of the Concession). The first water monitoring was coordinated as part of the Hydrology Baseline; delivery of reports to all competent Institutions (MARENA, MEM, Municipalities and MINSA), a meeting was held with the Santa Rosa del Peñón Municipality on the preparation of the project profile document and PGA to be presented to MARENA; tree cutting activities were carried out in the sector on the way to mestiza as part of the safety to workers, since, due to rains, there were several incidents of falling trees; property fencing activities were carried out and in April 8 forest fires were extinguished.

The "Oro Verde" nursery finished this quarter with a total of 8,888 plants, which are watered, fertilized and kept free of weeds and pests as part of plant maintenance, 250 plants were donated, and 403 new plants were reproduced from the forest species. Activities in the reforestation areas included cleaning, fertilization, irrigation and pest control. A total of 645 trees were used for planting in the reforestation area of the Concession La India and Real de la Cruz, 344 plants were also replaced.

Environmental Management System implementation

3.2.1.1. Environmental Awareness

This quarter, 5-minute talks were held during the period from April to June, on safety, environmental and social issues, with the support and coordination of the social area, training was carried out for environmental personnel on planting techniques planting carried out by MEFCA and a diploma course on Technologies to improve agricultural production and productivity began in June, also coordinated by MEFCA with the support of experts on the subject- which lasts 16 weeks- this with the objective to improve the knowledge of workers who carry out reforestation and nursery maintenance activities, guaranteeing a higher percentage of

plant survival. An activity was also carried out at the company's facilities on recycling day; support was provided to MARENA to Earth Day celebration; and Ing. Heidi Vallecillo from the environment area represented Condor Gold at the mining fair as a panelist on the good environmental practices that the company has implemented to achieve the sustainable development of mining.

Other activities related to environmental awareness were the donations to the León Zoo that included food for birds.

Plants were also delivered to INAFOR and Community members in support of the activities of the national reforestation plan and environmental awareness issues led by INAFOR in the communities near the project.

3.2.1.2. Waste management program implementation

During this quarter, activities related to waste management continued at the La India concession and at the company's facilities

During this quarter, 1,040 pounds of general waste were collected; of which 2,040 lb of organic waste was generated, sent to the municipal dump and glass, paper-cardboard and plastic were stored for recycling with a total of 240 lb, which will be delivered to sites authorized by MARENA. Hazardous solid waste has also been generated (barrels of oil, barrels of hydrocarbons, oily rags, among others), for which removal will be managed with companies authorized by MARENA.

During the daily 5-minute talks, in the Quarter, the information plan continues on topics related to Environmental Management in order to raise awareness among all the Company's workers and prepare them for the next stage that the Mina La India project, where environmental management will be more wide ranging.

3.2.1.3. Soil protection and biodiversity conservation

As part of the biodiversity remediation and conservation efforts, Condor continues with its tree nursery in La India concession. Likewise, Cóndor continues to implement reforestation plans in 9,272 ha located in Nance Dulce, Soledad de la Cruz and Los Rastrojos in agreement with property owners and in the processing plant sector owned by the company. During this quarter, the reforestation plan included maintenance activities such as irrigation and fertilization, removal of weeds and replacement of lost trees, establishing and expanding a new reforestation area located in the processing plant sector, corresponding to compliance with the environmental authorization of the drinking-water plant issued by MARENA León.

Condor continues with its monthly donations to the Arlen Siu Zoo in León implemented since the fourth quarter of 2019, as part of Condor's commitment to the protection of biodiversity, mentioned in section 3.2.1.1.



In addition, as part of the soil protection program, maintenance was carried out on the different properties of the company, cleaning weeds, cleaning sediments on the road to the processing plant sector and at the entrance of Alfa 6, maintenance of viewpoints, planting of plants on slopes of viewpoints to avoid erosion, cutting of trees on the way to Mestiza in vulnerable areas that threatened the lives of workers or danger to company vehicles.

3.2.2. Tree Nursery "Oro Verde"

The "Oro Verde" nursery provides trees for all the reforestation areas in Condor concessions. At the end of this quarter, a total of 8,888 plants were watered, fertilized and cleaned of weeds and pests as part of the nursery maintenance program.

This quarter we have germinated seeds of oak, basilillo and melina species, generating 403 new plants, which have been monitored and have been given maintenance. In addition, this quarter work continues to be carried out to reduce the pests that affect plants.

3.2.3. Implementation of reforestation plans and other activities in the concessions

Activities in the reforestation areas included cleaning, fertilization, irrigation and pest control. A total of 407 trees were used for planting in the reforestation area of La India and Real de la Cruz Concessions.

As part of the reforestation commitment of 200,000 plants - which La India Gold SA agreed in the EIA before MARENA of the mining exploitation project Mina la India, and according to the agreement reached before this Institution- 257 plants have been donated to Institutions such as INAFOR and the Mayor's Office, which are taken into account for such commitment.

3.2.3.1. La India concession

a. Reforestation activities

Maintenance continues in the reforestation areas in Nance Dulce, Los Rastrojos and within the company's processing plant sector property. This activity is necessary to ensure the survival of planted trees and it is part of the company's environmental commitments within La India mine environmental permits, for exploration in La India and the environmental authorization for the processing plant sector.

Activities in the reforestation areas included cleaning, fertilization, irrigation, pest control. A total of 645 trees were planted on the properties of Carmen Rios and plant sector, 230 plants were replaced on the properties of Hellen Laguna, Oscar Rios and Carmen Rios.

3.2.3.2 Activities in Real de la Cruz concession

a. Reforestation activites

Maintenance of the reforested area in Soledad de la Cruz continued. This included irrigation, weeding, fertilization and pest control on trees. A total of 114 trees were replaced.



3.3. OTHER ACTIVITIES

1. Tree cutting in the Concession Espinito mendoza

Tree cutting was carried out in Tatiana, on the way to Mestiza, for the safety of workers and company vehicles, since due to the heavy rains we had several incidents of fallen trees.

2. Inspection Visit by the Institutions

2.1 MEM inspection visit

As part of the functions carried out by the Ministry of Energy and Mines, an inspection was carried out due to a complaint filed by Mr. Jeronimo Bonilla, owner of the farm called Real de la Cruz, in which he denounced illegal extraction from artisanal miners who do not have authorization. It should be noted that the company accompanied the inspection as owners of the Concession and having an environmental permit within the area.

3. Participation of the environment brigade to put out 8 forest fires and fencing of properties.



4. Meeting with Santa Rosa del Peñón Mayor's Office representatives to plan and elaborate a project profile and EIA of the landfill donated to this Institution.



5. Representing Condor Gold: Participation of Eng. Heidi Vallecillo, environment area, at the Mining Fair 2022 as panelist on the topic of good environmental practices implemented by the company to achieve sustainable mining development.



6. Support activities for other areas of the company

Support activities were carried out for all company's areas: cleaning and burning of weeds in viewpoints and drinking-water plant sector, support for hydrology in piezometers, support to acquisition area in delivering water bottles to El Bordo and Nance communities, maintenance of company properties, removal of sediments on the road to plant sector and Alpha 6 entrance.



Fresh Water Program in the Santa Cruz of La India community

The program continues to benefit the population through the Agua Fresca program, which delivers bottles of water for consumption on a weekly basis to the families from Mina la India and Agua Fría.

In 375 households they receive the benefit, which represents 458 families, since 83 multihousehold families benefit.

The program benefits 120 households with vulnerable relatives (elderly people, people with disabilities).

Activities within the water program:

- Delivery of two bottles weekly to 458 families.
- Enrollment of 6 beneficiaries in the program.

• 5 institutions received the bottle of water weekly (educational centers, health post, churches).

• As part of the relationship, the program gave details to the mothers benefiting from the program, celebrated on Nicaraguan Mother's Day.

• The beneficiaries received a message about the correct use of water, care and use of bottle and dispenser.







Program - Agua es Vida

During the second quarter of the year, El Agua es Vida program carried out the following actions in favor of the health and well-being of the population of the Mina la India community.

WATER: the program has joined actions carried out by the institutions in charge of the drinking water project for the population of Mina la India, visiting all the families of the community to invite them to participate in different assemblies to know the progress of the project, in addition to receiving training given by the New FISE on Law 277 (Special Law of Drinking Water and Sanitation Committees).

COMMUNITY HEALTH: the program made a request to MINSA in the first quarter of the year to improve care at La India's health post with the assistance of a permanent doctor to strengthen care, for this second quarter the post already has a permanent doctor and the assistance of one more nurse, an action that has improved care and for which the population's attendance at the health post has increased. These results have been achieved through good relations with the corresponding institutions.

DENGUE: Through this program, awareness-raising actions have been carried out to eradicate mosquito breeding sites, the participation of local actors, churches, MINED and residents was requested; natural weeds were cleaned at the health post, house-to-house visits are carried out to invite them to keep their homes clean and the collaboration of people who exercise leadership has been asked to sensitize the residents to join the campaign against dengue.

RECYCLING: With the project cleaning and recycling in the community in the second quarter of the year, the program has managed to prevent 358 pounds of plastic bottles from contaminating the community's water sources and streets. In coordination with the Gonzalo García Vallejos educational center, activities were carried out with the aim of promoting the classification of waste in secondary school students.

Business Program

In December 2017, the initiative was born by the company to work with local businesses in the community where the project is located, to prepare them so that they can face the demand when the company becomes one of the largest mines in the country.

Currently the board of directors is made up of 4 members, coordinated by a social technician, with two axes as a horizon: Education and financial training. In which they focus to carry out the activities that are scheduled.

In June, a review was made of the people who are enrolled in the program, but who have never participated in any of its activities, they only wait for staff to visit their home and sometimes they respond poorly. Thus, 55 business owners remain active in the program, with whom they work from 4 areas:

- Bi-monthly training, visits and workshops for the 55 members of the program.
- Community savings; 24 members do so through bank accounts and 14 through piggy banks.

• Santa Cruz de la India Communal Bank, 23 members of the program, which make loans with monthly interest.

• 4 people rent community rooms. They are encouraged to participate in the different activities, according to their commitment to the program, so that they learn and put it into practice new skills in their business.

INDEPENDENT ARTISANAL MINERS INVOLVEMENT GROUP

Artisanal mining, activities with the board of directors Independent Miners.

Work continues alongside the independent miners who have the benefit of exploiting ore within the company's property, known as La Mestiza. This is as long as they comply with the regulations and provisions that the company, through its artisanal mining team, enforces on this property.

Activities with group of independent miners (MESTIZA)

During the second quarter of 2022, the number of 64 artisanal miners organized in 13 groups benefited from a free access agreement to La Mestiza property based on a contract made to carry out artisanal mining tasks until July 17th, 2022.

Production in the second quarter of the groups benefiting from the access and extraction agreement was 468 tons of ore with an approximate grade of 5.00 gr per ton. Maintaining an average of 156 tons per month, although the rains persisted during May, few groups stopped working and if they did it was momentarily, during this rainy period the artisanal mining team

provided supervision to the mining work, giving its recommendations. and anticipating any accident, performing hazard identification and risk assessment at each job site.
