Condor Gold has developed an internal prevention protocol with our employees, which includes sanitary measurements within the installations and towards the surrounding communities, such as:

- Talks given and written pamphlets on sanitary measurements and COVID-19 prevention were distributed to employees.
- Avoid social gatherings as much as possible and promote social distancing in common areas.
- Use of masks for employees is obligatory in the installations and villages.
- Cleaning outside and inside of vehicles after each use.
- Alcohol spray (small) is distributed for all employees and for desk/computer cleaning.
- Benzalkonium chloride is distributed for all the employees to use in their houses to clean surfaces.
- Disinfectant booth, washing hands, shoe disinfection and thermometers are used at the entrance of the offices.
- Suppliers are met outside the office areas to reduce contact with employees.
- Guidelines for kitchen area and cleaning procedures have been modified and the use of common items has been eliminated.
- Villagers in the social programs and local schools have received talks, as well as sanitary supplies (alcohol, chlorine, etc).

As of June 2020, Condor Gold arranged for employees to work from home and reduced activities on site to avoid spreading of Covid-19 and ensure the safety and health of its employees. This also include reduction of social interactions in the social programs.

Executive summary

The following report covers the period from April to June 2020, including the environment, social, health and safety and human resources areas.

Condor continues to implement its Environmental and Social Management System, which includes Environment, Community, Health and Safety and Human Resources. Work was focused on environmental awareness to employees and villagers in the social programs, maintenance of reforestation areas, maintenance and repairs of the tree nursery, waste management implementation including recycling, and cleaning activities. Environmental monitoring continues for La India, America and La Mestiza projects, including groundwater, surface water and weather data from our digital weather station and three other rain gauges.

The tree nursery “Oro Verde” holds a total of 7338 plants, which are watered, fertilized and kept clear of weeds and pests as part of its maintenance program, as well as, seedlings were plated out. This quarter, a total of 100 plants were donated to government institutions for reforestation, and social activities. Activities in the reforestation areas included cleaning, fertilizing, watering, fencing, fire breaks, pest control and installation of signs for water protection.

During the second quarter of this year, the social area continues to work on strengthening our social license with villages neighbouring the mining project through various relationship programs and various communication actions with interested parties.

The company's social investment has focused on social programs: Contributions and Donations that address issues related to education, health, sports, among others, during the period 51 contributions were delivered to people and organizations; Agua Fresca benefits 362 families from Santa Cruz de la India, Agua Fría and 26 property owners; Seniors program has 78 members; APROSAIC works with the villages neighbouring the project; Agua es Vida has 153 members; Businesses program has 68 Entrepreneurs; Artisanal mining that benefits 277 artisanal miners organized in 65 collectives; Youth in Action that benefits 28 youth and Happy Childhood that benefits 28 children.

This quarter, Condor carried out activities that allowed us to strengthen our relationship with villagers, generating trust and ownership in the project, such as the coronavirus prevention campaigns through all programs, carrying out preventive actions, starting by ourselves and thus serving as an example to the villages.

During this quarter, a press release was also shared on our website about the latrine construction project.

The company continues to support training and capacity building of its employees, providing financing and scholarships for English courses, master’s programs and daily training talks.

1. INTRODUCTION

This report is part of Condor Gold’s commitment to continuous improvement and monitoring of the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social and Community Relations, and Human Resources; ensuring transparency with its shareholders and relevant stakeholders.

2. OBJECTIVE

To inform stakeholders about the implementation of the Environmental and Social Management System in the areas of Environment, Social and Community Relations, and Human Resources during the second quarter of 2020.

3. ENVIRONMENTAL ACTIVITIES

3.1. ENVIRONMENTAL MONITORING

3.1.1. Baseline studies

Condor Gold continues conducting groundwater level and surface water flow monitoring, as well as gathering weather data from its digital weather station and three rain gauges (La India, Agua Fría and La Mestiza locations).

Surface waterflow

Monitoring of weirs continues. Constant water flow is only present in San Lucas V-notch weir (LIWR001), which showed an increase from 15 cm in the last quarter to 15.6 cm in June. Rainy season began mid-May with strong rainy events during that month. Intermittent water flow was observed in the remaining weirs (Photos 3.2.1.a-e).

Groundwater level monitoring

Weekly monitoring continues. In total, 26 sites are being monitored in 2nd quarter 2020. One new site was included, located in Nance Dulce village.

In April, two sites that were inaccessible due to the landowners locking their access, have been re-included, but sometimes there are still access problems. 17 sites showed a decrease in groundwater level between 5.69m and 0.02 m. LIWL057 showed the highest variations during the month, which is a hand-dug well in use for cattle. Four hand-dug wells showed an increase on water level between 0.3m and 0.01m.

In May, a new site was added located in Nance Dulce village. 14 sites showed an increase in groundwater level between 0.02 m and 9.92 m. LIDC379, showed the highest variations during the month, this drill hole has shown this kind of behaviour before, with strong rain events. 8 sites showed a decrease on groundwater between 0.01 m and 3.0 m, corresponding to hand-dug well LIWL057, usually used for cattle.

In June, 17 sites showed an increase in groundwater level between 0.01 m and 5 m. LIWL063 showed the highest variations during the month. 6 sites showed a decrease on groundwater between 0.02 m and 12.56 m, corresponding to drill hole LIDC379, same behavior as in May. LIDC317 was buried, possibly vandalised and no measurements can be taken.

LIDC291 showed no changes in groundwater level, LIGT250 and LIWL10 continue to be dried.

Weather data

During this quarter, the rainy season started mid-May. Condor continues registering data from the weather station and three rain gauges located in Agua Fría village, La India village in La India concession and one in Espinito-Mendoza concession.



The mining district La India is located in the dry corridor; therefore, average rainfall is 1200 mm/year, with the months of May, September and October as the strongest rain events. Below, a graphic of precipitation per year:



3.2. ENVIRONMENTAL MANAGEMENT

Condor continues implementing the Environmental and Social Management System, in compliance with internal policies and international standards.

In April and May, activities were focused on the reforestation plans, maintenance of the tree nursery “Oro Verde”, waste management, talks with employees, celebration of the International Earth Day with employees, support to the land acquisition team plus inspections to municipal waste dump relocation and waste management in the new properties of LIISA, support to the social team in talks to villagers and follow up on the medicinal garden project of the Seniors program. Support to government institutions in their environmental campaigns.

In June, Condor established a partial suspension of activities for four weeks due to the Covid-19 pandemic in the country. Employees were assigned to work from home and minimum activities were kept on site in La India project. The environmental area reduced activities, focusing on monitoring of groundwater and surface water level, weather data, maintenance of the tree nursery “Oro Verde”, and maintenance of three reforestation areas located in Los Rastrojos, Nance Dulce and ALPHA 6, all located in La India concession.

3.2.1. Environmental Management System implementation

3.2.1.1. Environmental Awareness

Condor implemented environmental awareness and environmental education activities in April and May, following all sanitary measures required and implemented by the company.

The International Earth Day was celebrated with co-workers in the tree nursery “Oro Verde”, a workshop on latrine use was given in Talpetate and Tanque villages, where the company installed 40 latrines as part of the social program. Two cleaning activities took place with co-workers and artisanal miners, where 153 bags of general waste were collected and 24 bags of plastic bottles. One cleaning activity was done to celebrate Recycling Day in collaboration with co-workers.

Also, three signs to protect water sources were installed in the reforestation areas. And eight signs related to waste management, fire prevention and reforestation were donated to the San Isidro municipality.

3.2.1.2. Participatory Water Monitoring Program

Due to the pandemic situation in the country, sampling for the Participatory Water Monitoring Program were rescheduled for July.

No representatives from the institutions will be invited to participate due to the current Covid-19 situation. Representatives from the villages will be waiting at the wells located in their villages. The sampling will include a request from Agua Fría village, presented through the social team.

3.2.1.3. Waste management program implementation

Activities related to waste management continued in La India concession and in the company's premises during this quarter.

Recycling and composting activities continued, recycling continues internally as well as with the villages. A total of 40 lbs of recycling material were gathered internally. General waste was about 200 lbs/month in camp, and 40 lbs/month of organic waste used for composting. General waste final destination is the municipal waste dump. Waste that can be recycled goes to the Los Pipitos recycling program and organic waste goes to the composting area located within the company.


3.2.1.4. Soil protection and biodiversity conservation

As part of the remediation and biodiversity conservation efforts, Condor continues with its tree nursery in La India concession. Also, Condor continues implementing the reforestation plans in 5 ha located in Nance Dulce, Soledad de la Cruz and Los Rastrojos villages under agreement with landowners. During this quarter, the reforestation plan included maintenance activities such as watering and fertilizing, weed removal, fencing and firebreaks to protect the area of potential forest fires.

Condor continues its monthly donations to the Arlen Siu Zoo in León implemented since last quarter 2019, as part of Condor’s commitment to the protection of biodiversity.

3.2.2. Tree Nursery “Oro Verde”

The tree nursery “Oro Verde” provides the trees for all reforestation areas in the Condor concessions. During this quarter, a total of 7,338 plants were watered, fertilized and clean from weeds and pests as part of the maintenance program of the tree nursery Oro Verde. Also, planting out of 232 seedlings was achieved, of the following species: 124 Marango tree, 70 African Mahogany, 38 Reed fistula, and 10 Cortez trees and 110 white Guanacaste trees were replanted.

Also, the tree nursery was affected by the strong rains and measurements to avoid water run-off were implemented.

3.2.3. Implementation of reforestation plans and activities

3.2.3.1. La India concession – reforestation activities

Maintenance of reforestation areas in Nance Dulce, Los Rastrojos, and within the company’s property continues. This activity is required to ensure the survival of the trees planted and are part of the environmental commitments of the company in the La India environmental permit.

This maintenance includes watering and fertilizing, weed removal, fencing and firebreaks to protect the area of potential forest fires. As well as the installation of signs to protect water sources, and testing of alternative irrigation systems such as a drip irrigation system in one of the areas.

3.2.3.2. Real de la Cruz concession – reforestation activities

A visit was conducted to the landowner of the first 3ha of the reforestation plan, who last year did not want to continue with the activity and denied access to the company. A survival inventory was completed and only 186 trees survived in 3 Ha, out of 1315 trees planted, 14% survival rate. This area, located in the dry tropics, has very poor topsoil and plants require a lot of maintenance so survival rates were very low.

Two new areas were evaluated, including reforestation of a water reservoir located within the property. Another area was evaluated in another landowner's property.

Maintenance of two reforestation areas in Soledad de la Cruz village continued, which included watering, fertilizing, and weed removal. 103 new trees were planted due to losses.

In March, a donation was made to San Isidro municipality and INAFOR for the Inauguration campaign of the Forest Fire Prevention.

4. SOCIAL ACTIVITIES

4.1. STAKEHOLDERS ENGAGEMENT IMPLEMENTATION

4.1.1. Meetings with local stakeholders

During this quarter, the company held more than 27 meetings with the leaders of the social programs to coordinate the activities developed with the members of the programs and the village in general.

Main topics addressed were:

4.1.2. Bilateral meetings with local stakeholders

Bilateral meetings

During this period, the company held 24 bilateral meetings, with local organizations in the Area of Direct Influence (ADI) and with NGOs and/or institutions interested in collaborating with social programs.

4.1.3. Artisanal mining

Within the artisanal mining program, the following activities were carried out:

a) Miners' Board of Directors' activities (COOPTRAMIN)

- ✓ **Wellness workshops**

Due to Covid-19, health circle dynamic was changed for this quarter as part of the measures implemented to prevent the spread of Covid-19, such as the suspension of activities involving large numbers of people. Therefore, health circles resumed with the modality of visiting health circle members house to house to deliver the workshop and provide them with a hygiene kit (chlorine and hand soap). Also, anti-flu tea pack (tisane tea) was given to each member visited.



✓ **Successful youth**

During the house to house visits to dance group members, it was identified that some members from El Cristalito, daughters of artisanal miners, were making liquid soap in their homes to keep personal hygiene to prevent covid-19.

After internal discussion, Condor Gold and COPTRAMIN involvement group will promote these 6 teenagers as a pilot project to elaborate hand sanitizer and liquid soap. Teenagers will have Condor's support by training them in basic business topics and provide raw materials to develop a production batch as a seed capital. They will have to designate part of the profits earned to supply hand sanitizer and liquid soap to local schools as a social responsibility.

The group was formed, but a meeting with their parents is pending. Also, raw materials are being purchased as well as materials to make the products. Additionally, a local person (from El Jicaral), who has a master's degree in Evaluation and Development of Medicines in the Pharmaceutical Industry (University of Salamanca, Spain) will supervise the process for a symbolic price, since she wants to support local talent.

b) Activities with the Board of Independent Miners who work in La Mestiza

✓ **Repairing road to La Mestiza**

Board members organized its group members to raise money to repair the road to Mestiza before the rainy season began. This activity improved the critical part of the road for a total of 900m length, artisanal miners covered 100% of the cost.

✓ **Cleaning campaign with cyanide ponds owners**

As part of the supervision undertaken of cyanide ponds in property recently acquired, a cleaning campaign was conducted on the 14 cyanide ponds owners working in the property. The cyanide ponds will relocate in August, and the company will conduct a closure plan in the area with the government institutions MARENA and Santa Rosa del Peñón municipality.



✓ **Artisanal miners census in La India mine district**

The presence of artisanal miners is allowed by the Nicaraguan Mine Law, Law 387, in 1% of the area of any mining concession. Concession holders have a duty to report artisanal miners presence in their concessions and any other activity related to the Ministry of Mines and the Ministry of Environment. Condor Gold began updating the artisanal mining census at extraction sites located in the concessions La India and Espinito-Mendoza, located in La India mine district.

A total of 1,035 artisanal miners organized in 217 groups have been counted, with a total of 90% of the areas covered. There are twice the number of artisanal miners than the ones identified in 2018 census (515 miners) in 100% of the concession areas surveyed. In La India concession, Las Naranjas site is pending. Also, the extraction sites in Real de la Cruz, Cacao, La Cuchilla and Rodeo concessions are pending.

4.1.4. Communication campaign

During the second quarter, Condor continued executing the communication strategy using various methodologies such as: assemblies, bilateral meetings, home visits, Facebook, YouTube and website. By using these communication channels we managed to be in direct contact with the population and spread our work.

As part of the public relations strategy, a press release was published on project's website called:

“Condor Gold benefits families from villages of Santa Rosa del Peñón with latrine construction project”



4.2. COMMUNITY RELATIONS PLAN IMPLEMENTATION

La India Gold SA developed a social investment plan, oriented to generate conditions to promote better relationships in the areas of direct and indirect influence of the project; with a focus on water, communication, support for small mining, among other contributions and programs.

During this quarter **the investment was U\$ 47,200.00** in the following items:





Fresh Water Program in the Santa Cruz community of India

During the second quarter, the weekly water delivery program continued to be developed. The delivery of two free potable water canisters and two subsidized potable water canisters continued throughout the quarter, directly benefiting 389 households in Santa Cruz de la India and Agua Fría villages. These villages are in the area of direct incidence to Mina La India project.

Support was also provided to vulnerable sectors: Seniors, people with disabilities and multi-household families; through the free delivery of potable water canisters. This program contributes in reducing water shortage and intestinal diseases, providing villages with good quality water for consumption.

During the last month of the quarter, water was delivered at a “delivery point” in each village as a Covid-19 prevention measure.

In Santa Cruz, 2,785 potable water canisters have been delivered during this period (April to June).

Activities within the water program:

- 216 mothers from Santa Cruz de la India received a gift (cake) in celebration of their day.
- 262 families continue to receive their water canister weekly.
- 262 families received recommendations on bottle and dispenser cleaning to prevent contagion from viruses.
- Program beneficiaries were informed through the quarterly magazine “La Voz de la India”.
- During the delivery, information was provided regarding the programs that are being executed, such as medicinal garden, sale of medicine, work that has been carried out in coordination with the Ministry of Health and Education, among others.
- Information on prevention measures against Coronavirus was given during the delivery of the canisters.
- Dispensers were delivered to new enrolled beneficiaries.

Fresh Water Program in the Agua Fría community

Fresh water program reaches every home in Agua Fría village; also benefiting permanently, and exclusively, families where there are older adults and people with disabilities.

1,204 cannisters of purified water have been delivered to the village in this second quarter of 2020.

Activities within the program:

- 116 mothers benefiting from Agua Fría village received a present in celebration of Mother’s Day.
- 127 families receive their potable water canisters weekly.
- 125 families received recommendations on cleaning the canister and dispenser for virus spreading prevention.
- Delivery of quarterly magazine “La Voz de La India” to program beneficiaries.

Program - Agua es Vida

The Agua es Vida program has focused on 3 main axes: water, village health and education. Therefore, for this quarter, different activities have been carried out that contribute to the strengthening of such axes.

In 2019 and early 2020 a recycling project was implemented with the aim of minimizing impacts of waste on streets and in streams, dissemination of different measures for cleaning houses and streets through dynamic competition, this contributes to improve the quality of health. Different efforts with corresponding institutions to find a solution to the water problem in the village and development of different topics such as the correct segregation of solid waste

contributes to strengthening knowledge of children, youth and adults, as well as information campaigns on the prevention of COVID in homes.

APROSAIC

APROSAIC has focused its work on cultural initiatives, strengthening relationships with community leaders, local schools, and cultural activities. During this month, APROSAIC focused on executing activities in cultural courses. The activities in detail below:

Culture

✓ Dance course – Grupo Raices Doradas

Due to Covid-19, dancing course was suspended on March 26th. Therefore, APROSAIC members and Condor Gold held house to house visits to dance group members to deliver to them and their parents the recommendations given by WHO on personal hygiene and cleaning tips to help keep the Covid-19 virus out of their homes.

A total of 38 homes in Agua Fría, Santa Cruz de la India, El Cristalito, Los Rastrojos, Andrés Reyes, El Carrizal and El Bordo villages were visited and a flyer with WHO recommendation and 500ml of clorinhe were delivered with each home.



✓ Musical keyboard course

Due to Covid-19, musical keyboard course was suspended on March 26th. Therefore, APROSAIC members and Condor Gold held house to house visits to course students to deliver to them and their parents the recommendations given by WHO for personal hygiene and cleaning tips to help keep the COVID-19 virus out of their homes.

A total of 14 homes in Santa Cruz de la India, El Cristalito, El Carrizal, El Bordo communities were visited and a flyer with WHO recommendations and 500ml of clorinhe were delivered to each home.



Education

✓ Covid-19 Information campaign

APROSAIC and Condor Gold started an information campaign delivering the actions for Covid-19 Prevention and Control in Schools (recommended by WHO) in 9 schools nearby the La India project covering La India, El Bordo, Agua Fria, Tanque, Talpetate, El Carrizal, El Cristalito, Nance Dulce and Los Rastrojos villages.

The key messages delivered were the basic principles established by WHO and UNICEF, which can help keep students, teachers, and staff safe at school and help to prevent the spread of this disease; this include:

1. Sick students, teachers and other staff should not go to school.
2. Schools should enforce regular hand washing with safe water and soap, alcohol rub/hand sanitizer or chlorine solution and, at a minimum, daily disinfection and cleaning of school surfaces.
3. Schools should provide water, sanitation and waste management facilities and follow environmental cleaning and decontamination procedures.
4. Schools should promote social distancing (a term applied to certain actions that are taken to slow down the spread of a highly contagious disease, including limiting large groups of people coming together).

Local schools are applying the recommendation number 1 and there are 40% of attendance to schools since parents are reluctant to send children to schools for the risk of getting Covid-19.

Also, schools are striving for ensuring hand washing, but water scarcity is the main challenge to reach this goal; therefore, APROSAIC and Condor Gold delivered chlorine and spray bottles to ensure daily desinfection of classrooms and hand sanitation for students; through this action, 65 teachers and 1,500 students were benefited. Government guidance does not allow for schools to promote or implement social distancing and the regular sport leagues are on-going, which represents a high risk of contagion for students and teachers.



COMMUNITY LEADERSHIP

✓ Apostolates visit to older adults and people with disabilities

As part of the social work with communities' leaders, APROSAIC executed an apostolate journey with religious leaders from Agua Fria and El Bordo and held visits to people with disabilities in their communities.

In May, 6 apostolate visits were made in Agua Fria and El Bordo communities, visiting homes of vulnerable people explaining the ways of preventing Covid-19, praying for them, and delivering a package containing basic food and personal hygiene items.



✓ Covid-19 Information campaign for elderly mothers

Condor Gold and community leaders started an information campaign delivering the actions for COVID-19 Prevention (recommended by WHO) in 7 villages nearby La India project covering El Cristalito, El Carrizal, Los Rastrojos, Andrés Reyes, Nance Dulce, Agua Fría and El Bordo; using the Mother's day to reach 133 elderly mothers, who are a vulnerable sector of the population. Also, a food package was given to each elderly mother, and they were thankful for the recommendations and the food package.



Youth in Action Program

During the second quarter of 2020, activities have been carried out in the different axes focused on creating spaces for development, recreation and change for the youth of Santa Cruz de la India. As of June, only telephone monitoring actions have been carried out with each of the youth members.

4.3. IDENTIFICATION OF VULNERABLE FAMILIES

Santa Cruz de la India's Seniors Program

During the 2nd quarter of 2020, the activities were focused on promoting hygiene recommendations provided by the WHO for the prevention of Covid-19.

Globally, there is a pandemic that mainly affects the most vulnerable people, the elderly. With the support of the company, the board of directors adapted and carried out activities in accordance with the context experienced by the health emergency.

As a prevention and safety measure, as the contagion curve in Nicaragua progressed, home-to-home visits for program members were discontinued and other means were adopted to disseminate information that would provide tranquility to older adults.

The medicinal garden projects continue to work, taking all hygiene measures and Piñatas project temporarily stopped its work.

We closed the 2nd quarter with 77 registered members, since 3 program members have died.
