Executive summary

The following report covers the period from April to June 2019, including the environment, social, health and safety, human resources, and land acquisition processes.

Condor continues to implement its Environmental and Social Management System, which includes Environment, Community, Health and Safety and Human Resources. Focus has been on promotion of environmental awareness with co-workers and villagers and celebration of World Environment Day, maintenance of reforestation plans and the tree nursery, waste management (composting and recycling) and environmental monitoring. Environmental monitoring continues for the La India project, including groundwater, surface water, water quality and weather data from our digital weather station and three other rain gauges. The Participatory Water Monitoring Program included a technical workshop and water sampling of 11 sites, with the participation of representatives from seven villages plus government institutions. Furthermore, the quarterly meetings with the villages were reinstated, to present the environmental, social and geology activities done in the first quarter of the year.

The tree nursery "Oro Verde" holds a total of 5127 plants, which are watered, fertilized and kept clear of weeds and pests as part of its maintenance program. Condor also installed an irrigation system with 24 water sprayers and expanded the tree nursery by 30% with bamboo wood. 519 new seedlings were added in May. 300 plants were donated to INAFOR- San Isidro, Matagalpa, 60 plants to San Isidro municipality and 150 plants to INAFOR-León in El Jicaral for their environmental and reforestation campaigns. Condor also received from INAFOR, 200 pine trees to support INAFOR's pine trees project.

Condor continues implementing the Reforestation plans for Espinito-Mendoza and Real de la Cruz concessions. During this period, maintenance was carried out in the reforestation areas and preparation for planting trees to compensate for losses during the dry season. In Real de la Cruz 424 plants were substituted during this quarter. Three new areas (5.9 ha) will be added for reforestation purposes: 2.9 ha in Real de la Cruz, 2 ha in Agua Fría and 1 ha in Nance Dulce.

The social area continues to work on strengthening the social license with the villages neighbouring the mining project through various relationship programs and various communication actions with interested parties.

The company's social investment of US \$ 49,516.63 for this quarter has focused on seven social programs: Contributions and Donations that deal with actions focused on education, health, sports and village mourning, among others; benefiting a total of 78 people and organizations. During this quarter, the Agua Fresca program benefited 339 families from Santa Cruz de la India and Agua Fria villages and 26 property owners; Elderly group with 79 members; APROSAIC that works with neighbouring villages to the project; Agua es Vida (which has 150 members); Small Businesses (52 entrepreneurs) and Small Mining that benefits 144 artisanal miners organized in 42 collectives.

This quarter, several activities were carried out which helped strengthen relationships with the villages, generating trust and ownership with the project, such as: celebration of Father's Day, World Environment Day, Mother's Day and Children's Day. These activities were conducted in collaboration with the involvement programs and were implemented in the villages of direct and indirect area of influence of the mining project.

During the period, Condor had 42 direct employees: 52% live in the local villages, 45% are women. 5 employees have been or are benefiting from a scholarship for English courses. Condor employs 32 people indirectly through the security company ESIPSA.

1. INTRODUCTION

This report is part of Condor Gold's commitment to continue improvement and monitoring in the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social and Community Relations, Health and Safety and Human Resources and transparency with its shareholders and relevant stakeholders.

2. OBJECTIVE

To inform on the implementation of its Environmental and Social Management System in the areas of Environment, Social and Community Relations, Health and Safety and Human Resources.

3. ENVIRONMENTAL ACTIVITIES

3.1. ENVIRONMENTAL MONITORING

3.1.1. Baseline studies

Condor Gold continues conducting groundwater level, surface waterflow and water quality monitoring, as well as gathering weather data from its digital weather station and two rain gauges.

A hydrology, hydrogeology and climatic study will be done for the proposed Tatiana open pit project area to comply with the Terms of Reference of the EIA application process. This study will be done in July 2019. Information related to surface water and groundwater levels will be gathered on site, and the two piezometers installed in La Mestiza during this quarter will provide further information for this study.

Surface waterflow

Monitoring of weirs continues. Constant water flow is only present in San Lucas V-notch weir (LIWR001), which showed an increase from 16.1cm to 18cm; a typical increase every rainy season (Photos 3.2.1.a-e). Even though the rainy season started mid-May, no constant water flow has been stablished in La Simona stream in Agua Fría.

Maintenance of the San Lucas V-notch was completed, the staff gauge was changed, and it is being checked to ensure accurate measurements.

Groundwater level monitoring

Weekly monitoring continues. Two new drill holes were added: LIDC379 (April) and LIDC374 (May). Both are located in La Mestiza property, in Espinito-Mendoza concession. This means that 21 of 27 sites are being monitored. Other sites continue to be inactive due to denial of access by landowners.

In April, 11 sites showed a decrease in groundwater level between 0.01 m and 2.02 m. The highest belongs to hand-dug well LIWL057 (located in El Carrizal village), which was in use, so variations can be expected. Drill holes also showed a decrease between 0.48 m and 0.15 m. An

increase was seen in three hand-dug wells of between 1.11m and 0.11m, and in drill hole LIDC317 of 3.93m.

In May, 9 sites showed a decrease in groundwater level between 0.01 m and 1.25 m. The highest belongs to LIDC379 (drilled hole located in La Mestiza). An increase was shown in 9 sites, between 0.01 and 2.94 m. The biggest increase was hand-dug well LIWL046, usually used for cattle.

In June, 10 sites showed a decrease in groundwater level between 0.07 m and 2.66 m. The biggest change was in LIWL046 (hand-dug well), which was pumped to water the cattle; followed by LIWL056, which was also in use for a rastra. An increase was shown in 10 sites, between 0.02 and 1.81 m. The biggest increase was in hand-dug well LIWL057.

Weather data

Condor continues registering weather data gathered from the digital weather station and two rain gauges located in Agua Fría village and La India village.

In June, a new rain gauge was added in La Mestiza property, in Espinito-Mendoza concession.

3.2. ENVIRONMENTAL MANAGEMENT

Condor continues to implement the Environmental and Social Management System, in compliance with internal policies and international standards.

This quarter, work was focused on the reception of quotes and selection of consultants for the baseline studies for the EIAs of the Tatiana open pit and America open pit projects, on the implementation of the Participatory Water Monitoring Program and promoting environmental awareness through different activities, such as the celebration of the World Environment Day. As well as, continuing the implementation of the waste management program, the reforestation plan, the tree nursery "Oro Verde", support to the social team in their environmental projects and attention to government institutions.

Condor also prepared and delivered the IFC quarterly report for the first quarter of 2019, an Environmental and Social Quarterly report for the website: www.condorgold.com and a Spanish version, which was shared with relevant stakeholders from different institutions in Nicaragua.

3.2.1. Environmental Management System implementation

This quarter, Condor continued implementing and promoting environmental awareness, environmental education, waste management (composting and recycling), water management and soil conservation through reforestation.

A part of promoting environmental awareness, this quarter, talks with workers were related to water monitoring (groundwater level, water quality), rainfall monitoring (rain gauges), forest fire prevention, remediation of trenches, migration of birds, benefits of trees, environmental facts, reforestation activities and celebration of World Environment Day. Talks with the villagers, in support to the social team, were related to the water footprint, water management and waste management; the public targeted were students, business owners and artisanal miners (from El Cristalito and El Bordo villages).

In April, the Participatory Water Monitoring Program covered the technical workshop on 9th April and the water sampling of 11 sites on 10th April, which included the participation of community representatives from seven villages and during the sampling; representatives of MARENA, MEM and local government (municipalities) also participated. The topics addressed during the technical workshop were focused on catchment management, hydrogeology, water quality, monitoring and environmental measurements for water usage.

Also, in April, the environment team collaborated with the social team in talks to students at the village schools on the water footprint; talks with business owners on water management and donation of 20 signs related to environmental measurements for water usage, and participation in the cleaning campaign of the El Bordo and Cristalito villages with artisanal miners and a talk on waste management.

In June, the presentation of the lab results was made in seven villages, involving a total of 443 people. During this, World Environment Day was also commemorated with villagers. The celebration consisted of talks related to the environment and the exchange of plants (fruit trees and ornamental plants) for plastic bottles - 385 plants were exchanged. Two other activities were completed as part of the World Environment Day commemoration: one with co-workers, through a reforestation campaign which took place in Real de la Cruz concession with 318 trees planted; the other consisted of a cleaning campaign in La India village on 4th June, organized by the social team and at which 56 participants collected approximately 22 bags of general waste and 65 bags of plastic bottles from La Simona stream. A new metal container for plastic bottles was installed in the Information Office to promote recycling in the villages.

Recycling and composting activities continued this quarter - worms in the vermicompost were eaten by rats and needed to be replaced. Recycling continued internally as well as with the villages. 15 lb/day of general non-recycled waste were generated in Condor's installations. A total of 139 lb of paper and cardboard were delivered to Los Pipitos NGO. A total of 978 lb of plastic bottles were collected in the two activities commemorating the World Environment Day with the villagers; these will be donated to the Los Pipitos NGO in July, as always. A total of 610 lb of plastic bottles were collected in the Cleaning campaign in El Bordo and Cristalito villages; these were donated in this quarter to Los Pipitos NGO.

As part of the remediation and biodiversity conservation, Condor continues with its tree nursery in La India concession and its water reservoir in Espinito-Mendoza concession, as well as the two reforestation areas in Real de la Cruz and Espinito-Mendoza concessions. This year, three new areas will be added for reforestation: 2.9 ha in Real de la Cruz as part of the compensation plan of the environmental commitments in the exploration EIA; one hectare in Nance Dulce village offered by an employee for reforestation in La India concession; and 2 ha in Agua Fría village, and close to the future processing plant. Maintenance was also carried out on the existing 8 ha reforestation areas in Espinito-Mendoza concession and Real de la Cruz concession. All these activities will add up to 5000 trees to be planted this year. All these activities contribute to biodiversity and water conservation, soil conservation and environmental protection.

3.2.2. Tree Nursery "Oro Verde"

The tree nursery "Oro Verde" provides the trees for all reforestation areas in the Condor concessions. Maintenance of the tree nursery continued, which includes watering, fertilizing and weed control. Condor also installed an irrigation system with 24 water sprayers and expanded the tree nursery by 30% with bamboo wood. 519 new seedlings were added in May.

A total of 5127 plants are left after the donations and reforestation activities during this quarter.

From Condor's tree nursery, 300 plants were donated to INAFOR- San Isidro, Matagalpa, 60 to San Isidro municipality and 150 to INAFOR-León in El Jicaral for their environmental and reforestation campaigns. Condor also received from INAFOR 200 pine trees to implement a pine tree reforestation project promoted by INAFOR. Pine trees are native to the area at higher elevations, e.g. La Mestiza but have all been lost over time. The project aims to re-establish the pine forest to its former extent.

Condor also participated in the workshop for the National Forestry Plan organized by INAFOR León.

3.2.3. Implementation of reforestation plans and activities

3.2.3.1. Espinito-Mendoza concession – reforestation plan and forest fire

In April and May, the maintenance of the 5 Ha reforested area and internal inspections continued with security posts located within the La Mestiza property to ensure that the waste management program is being implemented: i.e. latrines installed and waste containers being used correctly to comply with Condor's environmental policies and programs.

On 19th, 20th and 21st April, a forest fire spread from a neighboring property to La Mestiza property owned by CONDOR S.A. The fire spread quickly through 140 Mz, about 100 Ha. Since most employees were on leave for Easter, the Company could not attempt to control the fire, which continued to spread until it reached internal roads. The reforested area located within the concession was not affected, since a fire break was built around it in previous months. Condor has no confirmation as to who or what initiated the fire, but it appears to have come from a neighboring farm. Condor prepared and delivered a report to the government institutions and a site visit by INAFOR-León was conducted to evaluate a potential forest fire prevention campaign with landowners, as well as the selection of four locations to install prevention signs.

In June, maintenance was carried out in the reforestation area in Espinito-Mendoza and preparation for planting trees to compensate losses during the dry season. Focus will be put on the area which will not be affected by the proposed Tatiana project.

A reforestation activity with coworkers will be done on 3rd July to celebrate Miner's Day and the National Tree Day.

3.2.3.2. Real de la Cruz concession – reforestation plan

In Real de la Cruz concession, the reforested area of 3 ha suffered heavy losses during the dry season: 900 trees will need to be planted to ensure that the forest area is maintained. Preparation for the area with 467 holes and watering of the existing trees (since rainfall has been scarce) have been the main activities.

A new area of 2.9 ha will be fenced, and we will begin reforestation this year. This is part of the compensation plan included in the Environmental Permit for exploration of Real de la Cruz.

In June, 318 trees were planted by co-workers in the reforestation campaign in commemoration of World Environment Day and 106 cuttings were planted by the environmental team.

4. SOCIAL ACTIVITIES

4.1. STAKEHOLDERS ENGAGEMENT IMPLEMENTATION

4.1.1. Meetings with local stakeholders

During this quarter, the company held more than 46 meetings with the leaders of the social programs to coordinate the activities to be developed with the members of the programs and village in general. Main topics addressed were:

- Water program
- Senior program
- Social contributions
- Business program
- Small Mining

4.1.2. Bilateral meetings with local stakeholders

Bilateral meetings

During this period, the company held 38 bilateral meetings, with local organizations in the Direct Influence Area (DIA) and with NGOs and/or institutions interested in collaborating on social programs.

La India Gold SA is working towards the creation of Medicinal Plant Gardens with elders, further liaison will be carried out with the NGO to arrange visits and potentially training to seniors on the use of such plants.

We were informed that soon they will receive the offer of the courses of the 2nd semester and they will send us the course list to see if they are of interest.

4.1.3. Artisanal mining

Within the artisanal mining program, the following activities were carried out:

a) Miners' Board of Directors' activities (COOPTRAMIN)

Information meeting on the contributions and developed activities. During the second quarter,

an information meeting was held with each of the village groups, in addition to disclose CAO's resolution to each of these groups from Cristalito, Bordo and Santa Cruz de la India villages.

Environmental activity. Environmental Activity was conducted in coordination with the environmental area of La India Gold SA and the representatives from El Bordo and Cristalito villages. The activity was carried *Illustration* out with a total of 120 people, 100 bags full of plastic Collection of plastic bottles. bottles were collected; as part of the activity 2 piñatas were given per community in addition to refreshments. These collected plastic bottles are donated to the NGO Los Pipitos Organization.

Dental day. a dental day was held for miners' members of the cooperative COOPTRAMIN, where fillings, extractions and dental cleaning were offered. This activity was coordinated with UNAN - León. A total of 25 members participated

First sawdust carpets contest, total of 25 members. The first sawdust carpet contest was held in Santa Cruz de la India in which the boards of miners, both independent and cooperative, contributed with the elaboration of an entrance arch placed on the main street and presented an offering of fruits to the priest.

Sport Activity – flash tournament at Cristalito village with Cooperative Miners. In commemoration of Bordo festivities, in honor of the Virgin of Fatima, a flash baseball league was promoted with the Board of Miners in which 4 teams from Bordo, Cristalito, Rastrojos and Las Pilas villages participated.

Prizes were provided to the participants: first place (baseball bat and 6 balls), second place (6 balls), third place (5 balls) and fourth place (5 balls). The Cristalito team were the tournament winners.

Activity Celebration "Virgien de Fátima" in El Bordo village. As part of the celebrations in honor of the Virgin of Fatima, contributions were made by members of the Board of Cooperative Miners to the religious activities carried out in the village:

1. Rosary at the Silvio Rojas' House, delivery of 150 Refreshments and 4 dozen fireworks.

2. The "Celebration of the Word of God" in the local Church, delivery of 400 Refreshments and 5 dozen fireworks.

Mother's Day celebration with Cooperative Artisanal Mining involvement group. Taking into account mothers from the Cooperative Artisanal Miners Working Groups, the Board members, with support of the company, carried out the activity in commemoration of Mother's Day with the

participation of 19 mothers from Bordo, Cristalito and Mina la India villages.

As part of the Activity, Board members dedicated a few words to all the mothers, and highlighted the company's effort in supporting this kind of activities in which each of the Cooperative miners that are part of the activities are taken into account.

The final game was between Los Rastrojos vs Miners from La Mestiza team, the winner was Los Rastrojos team.

As part of the event, there were cultural dances by the Raices Doradas dance group, in addition a raffle of 5 tickets for attendance to the National Stadium took place. Teams were awarded with sporting equipment (gloves, bats and balls) to continue promoting sports in the villages.





b) Activities with the Board of Independent Miners and work in La Mestiza

Meeting with artisanal miners to read new provisions in the agreements:

- a) To inform the company's new provisions for the renewal of agreements, a meeting was held with each group, where 168 artisanal miners filled out entry applications. During this meeting, the agreements were read, and the following dates were established to carry out compliance with new conditions:
 - compliance with technical safety observations, compliance date 06/18/2019.



a. Reinforcement of labor and Illustration 100: meeting with group leaders to inform the company's dispositions to issue the new ore extraction agreements in the area of the mestiza.

- b. Groups of artisanal miners with their respective PPE: boots, helmets and glasses, date of compliance 06/09/2019.
- c. Registration of all miners to social security, compliance date 08/28/2019.

Inspections of risks at extraction sites is carried out in La Mestiza:

Within the activities carried out in June, a total of 13 extraction sites were inspected. 7 were served with relocation letters as they represented a high risk for artisanal miners, the rest were notified of risks presented in each of their extraction sites; the depth to which they are currently working and each of the characteristics in terms of maintenance and rock condition. This is to ensure improvements and avoid incidents or fatalities.

As part of La India Gold SA contribution made to artisanal miners there was a reopening for ore extraction in La Mestiza, where 168 artisanal miners are currently benefitting, these are grouped into 36 groups.

A census was conducted by the Ministry of Energy and Mines, General Directorate of Mines in Espinito Mendoza concession and in eight areas. 33 groups and 154 people were identified as members of these groups.

4.1.4. Communication campaigns

During this quarter, the company continued executing the communication strategy using different methodologies such as: assemblies, bilateral meetings, guild meetings, home visits, Facebook, YouTube and website. With the use of these communication channels, we managed to be in direct contact with the population and disseminate our work.

As part of the public relations strategy, five press releases of national interest were published:

- Condor Gold and APROSAIC work for the welfare of villages surrounding the Mina La India project
- Condor Gold celebrates Mother's Day in Santa Cruz de la India and surrounding villages
- Condor Gold recognizes important work of teachers in Mina La India and neighbouring villages.
- Condor Gold promotes actions for the care of the Earth.

The APROSAIC executives' directors held telephone interviews in five radios in León to publicize the work they have been carrying out with the villages in the different areas of work. Publications of press releases in national coverage media.





4.2. COMMUNITY RELATIONS PLAN IMPLEMENTATION

Fresh Water Program in Santa Cruz de la India

During this second quarter, the Fresh water program progressed: the delivery of two free water canisters and two subsidized water canisters each month was continued, directly benefiting 339 households in the villages of Santa Cruz of India and Agua Fría.

Also, support to vulnerable groups was provided: seniors, people with different capacities and multi-household families; through the free delivery of the four water canisters. This supports the reduction of the water scarcity problem and diseases.

2,507 water canisters of fresh water have been delivered in this period in Santa Cruz de la India village.

- Mothers who benefit from the program enjoyed Mother's Day celebration by the company.
- Children from families benefiting from the water program enjoyed a piñata in celebration of Children's day.
- Fresh water program recognizes the hard work of fathers as family pillars, celebrated on Father's Day with beneficiaries(s) of the program.

This quarter, a new medicinal garden pilot project started with the participation of 6 seniors, this pilot project aims to become a self-sustaining project that provides income to its members and that is very useful for the villages' inhabitants, since it will be the first garden that will provide natural medicine in the area.
