Condor Gold has developed an internal prevention protocol with our employees, which includes sanitary measurements within the installations and towards the surrounding communities, such as:

- Talks given and written pamphlets on sanitary measurements and COVID-19 prevention were distributed to employees.
- Avoid social gatherings as much as possible and promote social distancing in common areas.
- Use of masks for employees is obligatory in the installations and villages.
- Cleaning outside and inside of vehicles after each use.
- Alcohol spray (small) is distributed for all employees and for desk/computer cleaning.
- Benzalkonium chloride is distributed for all the employees to use in their houses to clean surfaces.
- Disinfectant booth, washing hands, shoe disinfection and thermometers are used at the entrance of the offices.
- Suppliers are met outside the office areas to reduce contact with employees.
- Guidelines for kitchen area and cleaning procedures have been modified and the use of common items has been eliminated.
- Villagers in the social programs and local schools have received talks, as well as sanitary supplies (alcohol, chlorine, etc).

As of November 2020, Condor Gold regained normal activities, all employees working full time, but with sanitary measurements and social distancing and sanitary measurements being implemented to avoid spreading of Covid-19 and ensure the safety and health of its employees and surrounding communities.

I. EXECUTIVE SUMMARY

CONDOR continues to implement its Environmental and Social Management System, which includes Environment, Community, Health and Safety and Human Resources.

In this quarter, environmental work continued to focus on the monitoring of the level of groundwater and surface water, monitoring of climatic parameters, leachate sampling for kinetic study of acid rock drainage, water management, waste management and recycling, maintenance of the nursery "Oro Verde" and maintenance of 8 reforestation areas (6 located in La India and 2 in Real de la Cruz concession). Daily 5-minute talks to environmental workers were carried out, and field staff participated in a workshop on Planting Techniques, taught by the central government through the MEFFCA. Until October the León Zoo was supported as part of the biodiversity program through MARENA.

Other activities included delivery of quarterly environmental reports to the corresponding institutions (MARENA – MEM – Mayors), the renewal of three special permits was obtained from INAFOR for the extraction of firewood for the benefit of the communities in the sectors of La India (Plant Area), Presa de Colas and Tajo Tatiana. Technical and administrative support to the mayor of Santa Rosa del Peñón was concluded within the framework of the efforts to obtain an environmental permit for the landfill site in an area donated by the company, as well as support in tree pruning and cleaning in the school and health center of the community of La India, plus support in operational activities requested by the different areas of the company (Geology, Social, Procurement, Hydrology and Administration).

In December the "Oro Verde" tree nursery contained a total of 6,687 plants, which are irrigated, fertilized and kept free of weeds and pests as part of its maintenance program. Activities in the reforestation areas included cleaning, fertilization, irrigation, and pest control. A total of 920 plants were donated under commitments made with INAFOR, 1,278 plants were transplanted, and 19 trees were replaced in the plant sector within the concession area of La India.

This report is part of Condor Gold's commitment to continuous improvement and monitoring of the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social and Community Relations and Human Resources, ensuring transparency with its stakeholders and relevant stakeholders.

The social area continues to work on maintaining the social license with the communities neighboring the mining project through various relationship programs and various communication actions with stakeholders.

The company's social investment has focused on social programs: Contributions and Donations, addressing issues related *inter alia* to education, health, sports, community mourning; during this period, 57 contributions were delivered to individuals and organizations. Agua Fresca program benefits 460 families from the Santa Cruz de la India village, Agua Fría village and 26 property owners. Seniors program has 85 members; APROSAIC, that works with the communities neighboring the project; Agua es Vida program, which has 135 members; Businesses program, with 52 entrepreneurs; Youth in Action program, which benefits 21 youth; and Happy Childhood, which benefits 40 children.

The company continues to support training and capacity building of its employees, providing financing and scholarships for English courses, and Masters programs.

II. INTRODUCTION

This report is part of Condor Gold's commitment to continuous improvement and monitoring of the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social and Community Relations and Human Resources, ensuring transparency with its shareholders and relevant stakeholders.

III. OBJECTIVE

To inform stakeholders about the implementation of the Environmental and Social Management System in the areas of Environment, Social and Community Relations, and Human Resources during the third quarter of 2022.

IV. IMPLEMENTATION OF THE ENVIRONMENTAL MANAGEMENT SYSTEM.

LA INDIA CONCESSION

a. ENVIRONMENTAL MANAGEMENT

This technical report contains the main activities carried out by both the hydrological component and the environmental area during the fourth quarter of 2022; these activities are executed according to the obligations of the company relating to the environmental permits acquired according to the corresponding stage (Exploration, construction, and / or production). The activities are designed to generate information before or during each of the mentioned phases and demonstrate the current situation of the different variables involved as a prelude to guarantee healthy practices during the development of the project.

In the context of generating information and reporting it both internally and to the governing institutions of the environmental legal framework at the local level, the information is presented by concession area in accordance with the requirements of current permits and their regulatory framework.

b. ADMINISTRATION AND PERMISSIONS.

1.1.1 Municipal landfill project.

- Completed the technical support to the Municipal Mayor's Office of Santa Rosa del Peñón in the preparation of the Environmental Management Plan and administrative management before MARENA and INAFOR. At the end of the quarter the culmination of the project is in the hands of the municipality of Santa Rosa.

1.1.2 Quarterly reports to government institutions.

- At the end of December, the management of information for the preparation of the quarterly report corresponding to the fourth quarter and the 2022 annual report began, as part of the commitments acquired in concession and environmental permits; scheduled to be delivered to the authorities by the end of January 2023.

1.1.3 Environmental permit.

- 920 plants were donated to INAFOR El Jicaral within the framework of compliance with the delivery of 200,000 plants established in EIA for reforestation.
- MARENA is given 150 pound (68.2 kg) of bird food from the Arlen Siu Zoo as a donation.

1.1.4 Special permits.

- Coordination of delivery of woody material through the forest regency consultant (LIGSA) and the social area for benefits of the community's people.
- Approved special permits of La India and Tailings Dam sector (TSF) before INAFOR, valid until July 2023.
- Attending the inspection visit of the La India concession by the Ministry of Energy and Mines (MEM) December 19th and 20th.
- Completion of the weekly training in training of environmental workers, in course on planting techniques given by the MEFC (Government).

1.1.5 Management of non-hazardous waste.

- 1,194 pounds of general waste, 672 pounds of organic waste and 522.5 pounds of recyclable material were produced in the camping areas located within the concession.
- The construction of a pit for the management of organic waste for compost continues in the Alfa 6 sector, at the end of the quarter completion is at 50%.

1.2 Nursery Oro Verde.

- At the end of the quarter, there was an inventory of 6,687 plants, managing a monthly average of 6,113, of these 920 were donated and 19 used for replacement in forest areas.
- During this period, the following maintenance activities were carried out:
 - Irrigation if conditions require it
 - Pest control through application of organic chemicals
 - Application of fertilizer
 - Pruning of plants
 - Preparation and mixing of organic soil (rice husks, black earth, and composting)
 - 1,278 plants were reintegrated or transplanted into new bags.
 - The concrete floor of the environmental warehouse was rehabilitated. (60 m2)

- Currently in the concession area of La India, there are six legal agreements for the implementation of forest areas, these are distributed within the 6,771ha concession, in addition to the plant construction area.

 - Mechanized weed cleaning (use of strimmer)
 - Burning weeds with chemical
 - Making holes and planting 19 plants
 - Application of fertilizers.
 - Irrigation during the month of December




Image 3.5.a Maintenance and repair of fences on properties

c. ENVIRONMENTAL MONITORING

1.5.5 Baseline studies

Condor Gold continues conducting groundwater level and surface water flow monitoring, as well as gathering weather data from its digital weather station and three rain gauges (La India, Agua Fría and La Mestiza locations).

1.5.5.1 Surface water flow

The monitoring of surface water levels continues in 6 different sites within the concession areas of the project, 5 located in the La India sector and 1 in the Americas sector.

- For this quarter continuous flow is recorded at the exit of the San Lucas tunnel located in the Ocotillo sector, the flow has been maintained permanently showing instantaneous peaks according to the behavior of precipitation.
- According to the registered data, the last quarter of 2022 shows the flows in the range of 33 to 78 lps, obtaining an average value of 50.02 lps however, given that during this period of transition from the rainy season to the dry summer season the trend shows that the flow begins its descent towards common values during the dry season, The average value increased by 18.81 lps compared to the previous quarter from 31.2 to 50.02 lps.
- Due to the decrease in rainfall in November and December, the average monthly value decreased 1.4 lps compared to the previous month, this trend will continue downward given the change of weather season in the country and the effect in the project area.




Figure 3.6.1.1 a. Behavior of flows vs precipitation in San Lucas Tunnel - Ocotillo.




Figure 4.9.1.2. Behavior of groundwater levels in La India concession.

4.9.1.3 Weather data

LIGSA carries out permanent monitoring of climate variables in 5 weather stations, four of them conventional and one digital, the values in the third quarter correspond to the rainy season in the country. The following is the information in the records.

- The digital station was temporarily out of service due to damage in data decoding components due to a storm in August. In September the process of acquisition of parts and tests with the supplier began, however, the main sensor presented failures.
- The process of repairing or purchasing this equipment has begun and the station is expected to be re-established in the first quarter of 2023.




Figure 4.9.1.3 a. Historical data of the Digital Station CONDOR S.A – 2020 – 2022




Figure 4.9.1.3 b. Comparative data from Conventional Stations – 2022




Image 4.9.1.5 a. measurement of physical water quality, collection, and storage of leachate volume.

- For the present quarter the temperature in each reactor was established in the range of 21 to 34 ° C, with an average value of 28.46 ° C, these values relate to the leachate process during the weathering of the minerals that may occur in the samples contained in each reactor and whose values are obtained by process of analysis of quality of leached water in laboratory, The following graph shows the temperature behavior for each reactor.




Figure 4.9.1.5 a - c: Behaviour of t°C within each reactor, fourth quarter 2022

4.9.1.6 La India – AGUA FRÍA Drinking Water Project

With respect to the drinking water project for India and Agua Fría, the Social Investment and Emergency Fund (FISE – government institution) concluded the feasibility phase by expanding to two more communities being Monte Verde and La Winston Castillo for an estimated cost of U\$ 4.9 M, which includes water and sanitation for a life span of 20 years with a population projection of 4,112 people. The project is currently in the hands of the central government to define its implementation strategy. The search for funds and approval can take about 1 year.

LIGSA has compiled information and technical and social advice requested by the institutions during the development of prefeasibility and feasibility studies.

2.3.1.2 Groundwater level monitoring

LIGSA performs weekly continuous monitoring of groundwater levels in 16 wells/piezometers distributed within its main concession areas.

- According to the geomorphological characteristics of the project area and the rainfall conditions during this period (October - November) the variation of static water levels in the current network for wells of intermediate depth (10 – 49 m) the values of levels fluctuated between 0.59 and 21.7 m, with an average value of 7.74 m.
- Regarding the water level in the excavated wells, the values of variation were established at 0.2m for both the minimum and maximum range, as well as for the average value.




Figure 4.2.2.1 a. Behavior of groundwater levels in La Mojarra concession.




Figure 5.2.1.2 a. Behavior of groundwater levels in Espinito Mendoza concession.






Figure 10: Men's Soccer Lightning League.

APROSAIC is a program that promotes and manages the economic, social, and cultural development of communities surrounding the mining project, which with the support of CONDOR GOLD-Mina La India and the collaboration of community leaders, actions are carried out that contribute to the improvement of the quality of life of citizens. Started in September 2017 and for this year its axes of work are: Health, Education, Culture And Community Leadership.

APROSAIC serves 6 communities surrounding the Mining Project, one (1) direct influence and five indirect (5). The program has a board of directors of 3 members, 20 community leaders and 15 health brigades.

INDEPENDENT ARTISANAL MINERS INVOLVEMENT GROUP

Work continues alongside independent miners who have the benefit of exploiting ore artisanally on the property of the company, known as La Mestiza and La India. This is permitted as long as they comply with the regulations and provisions that the company, through its artisanal mining

equipment, enforces in this property. In both properties 24 groups work who benefit from greater income for their families since they do not pay any percentage for extraction.

B. IDENTIFICATION OF VULNERABLE FAMILIES

1. Senior Citizens Program.

The Older Adults program is the first program in the municipality of Santa Rosa del Peñón and with the support of the Minero project, activities have been carried out that contribute to the mental, psychological and physical health of older adults in Santa Cruz de la India.

For the months of October, November and December the board of directors has carried out activities focused on 2 main axes: mental, psychological and physical health and self-sustaining projects.
